Swartz moved that the Board move to closed session. Scott seconded the motion and the motion carried.

Scott moved that the Board move to open session. Swartz seconded the motion and the motion carried.

Muller reported that the Board voted in closed session to increase the Full-time Captain salary to \$90,950 annually and the Full-time Firefighter/Engineer salary to \$68,650 annually effective in 2025 on their hire dates.

Santa will visit Denair on December 17 for a children's party and will take a fire truck ride through Denair on December 19 and 20.

Captain James Brewer retired from Denair Fire Department effective November 1, 2025.
