Volunteer staffing hours for 2024-25 totaled 8,670.

Modesto Fire Department Chief Kevin Wise sent a thank you note to the department for the help received during the September lightning event.

The Tri-Tip Barbecue hosted by the department on September 13, 2025 was a success.
